Happy New Year!

I hope you will take a minute to fill out the enclosed short survey and send it back to our new Chairman, Joe Stehling, in the self addressed stamped envelope provided. As mentioned in a previous bulletin, Joe is trying to contact as many Tree Farmers as possible to get their thoughts on the program and how to make it more relevant for members.

The American Tree Farm System (ATFS) is celebrating its 70th Anniversary in 2011. The world has changed a lot in the last 70 years and the ATFS has changed as well. The overall goal of encouraging forest land owners to manage their forest has not changed. What also hasn't changed is the critical need for forest management. What has changed are the reasons that people have for managing their forests. When the ATFS began 70 years ago there was a critical need for wood products from private forest land. This need still exists but now-a-days the forests are recognized as having additional benefits to society such as clean water, wildlife habitat, and as open space in our increasingly crowded and developed world.

Here in New Mexico forest management can be a hard sell. Our wood products industries have pretty much evaporated so it's difficult for forest owners to find markets for products from their forest. Money is always a strong motivator and a source of income from their forests allows forest owners income that can then be re-invested into their forests. Forest management in New Mexico can also be a hard sell due to the slow growth of the forests in our dry climate. It takes years sometimes for a land owner to be able to see the benefits from a forest practice.

As members of the ATFS you have made a decision to actively manage your forests. If you have some specific examples in ways in which your forests have been improved by management please let Joe know so we can pass this on to other forest owners. The Tree Farm system has always been about recognizing good forest practices so we want to know what you have done.
