Over the past 15 years, Doris has been an absolute rolemodel, regarding sustainable-forestry and multi-use activities on her 160-acre property.

Doris' written, management plan identifies her top two goals as: a) to improve tree health and vigor and b) to reduce the risk of Mountain Pine Beetle (MPB). In that regard, Doris has actively implemented pre-commercial thinning actions (total of 135 acres from 2003 through 2017) and has aggressively minimized the MPB epidemic on her property. She participated in the State of South Dakota MPB "spotting and infested" tree-removal program (2003-2017) with 100% of infested trees being removed from her property. She has also volunteered to participate in other land-management organizations, such as being a member of the Forest Service Resource Advisory Committee.

We "congratulate" Doris on this award and thank her for her tireless efforts towards keeping our Black Hills forest healthy and sustainable for future generations!



DIRECTOR'S STUMP— Paul Schipke, SD Family Forests Association Chairman

It has been a great year for landowners. We have had plenty of moisture and are relatively free from the Mountain Pine Beetle epidemic. Now, I'm hoping for a "normal" winter, free of major storms, but yet providing our critical moisture.

There have been a lot of questions concerning relationships between South Dakota Family Forests Association (SDFFA), the American Forest Foundation (AFF) and the American Tree Farm System (ATFS). It can be confusing and following is my attempt to provide a little clarification.

The American Forest Foundation (AFF) is a legally organized non-profit organization located in Washington, D.C. It has been classified a 501c3 organization by IRS. The stated mission of the AFF is "to ensure the sustainability of America's family forests for present and future generations in conjunction with our strategic partners".

Although not its primary function, AFF monitors Washington DC activities and represents forest owners interests. It is prohibited from lobbying but it does provide technical and other information to law makers at critical legislative subcommittee meetings. AFF also advises its members and partners of proposed legislation and encourages them to become actively involved in issues that could affect private forest Landowners.

The AFF created and administers the program called the **American Tree Farm System (ATFS)**. This program was created in 1941 and has served several purposes during its 77 year existence. Currently it continues to carry out the mission of the AFF with major emphasis on providing certification of private forestlands. In practice, it is the only option for certification available for small private landowners.

Currently 45 of the 50 states have arrangements with AFF to administer the ATFS within their states. Not all states are qualified, or chose not to certify forestlands within their respective states. Some administer "recognition awards" for sustainably managed forestlands following guidelines under the ATFS. There are over 74,000 small forest landowners managing approximately 20.5 million acres of privately owned forests in the program.

In summary, the ATFS is not a standalone organization with legal status. It provides certification and technical help to private forest owners throughout the US.

South Dakota Family Forests Association (SDFFA) is a non-profit corporation organized under the laws of SD. It also has been classified a 501c3 organization by the IRS. It is bound by the same restrictions as the AFF and also is allowed to have all donations (including membership fees) classified as tax deductions for the donors.

South Dakota Family Forest Association is the successor organization to the Keep South Dakota Green Association that was started back in the 1950's. During this period, KSDG also became the state sponsor of the South Dakota Tree Farm Committee. In 1974, KSDG attained its 501 c3 nonprofit status and continued to operate up into early part of the 21st Century when became inactive. At this point in time, the South Dakota Tree Farm Committee continued to operate as an organization under KSDG's non profit status. In 2008, KSDG's corporate charter bylaws were altered and the mission of the corporation was narrowed to primarily address private forestlands in SD. It retained its 501c3 status by the IRS and commenced doing business as South Dakota Family Forest Association.

Directors Stump Continued

SDFFA's primary mission is "to encourage the maintenance, improvement, and sustainability of the long-term growth, quality, and availability of wood and other renewable forest resources from private forestlands; while protecting environmental benefits". The mission or purpose list other activities but concluded with "to promote the continuation of good forest stewardship through certification programs, avoidance of forestland fragmentation, and to support the multi-generational continuance on private forestlands."

SDFFA has entered a "Memorandum of Understanding" with the American Forest Foundation to administer the ATFS within the state of SD. Our organization is qualified to, and has the authority, to carry out the ATFS Program within SD. This program is currently the only avenue available to the private landowner to sell "certified wood products".

SDFFA is legally responsible for its activities within the state of South Dakota. With less than 10% of the necessary funding coming from AFF, the SDFFA is obligated to operate as a functioning non-profit organization to obtain the funds necessary to carry out its activities within the state. Although the bulk of the funding goes toward administering the ATFS, other money is used to advocate for private forest landowners within SD and for specific public education activities.

Hopefully that helps clarify the muddied waters. I encourage all of you to check out the websites of the 2 organizations and the ATFS "Program" on their websites.

We remain extremely thankful for all the volunteers and financial donors who support our organization. Thank you for all your efforts that have helped us continue. We will continue in the future to balance the real value to our Tree Farmers with the resources that are available.

SDFFA Fund Raising Committee Report

Several years ago when South Dakota Family Forest Association decided to go down the "Forest Certification" pathway, SDFFA also committed to finding a way to raise enough money to fund all the activities and administration costs that go along with certification.

Our committee spent much time and effort reviewing and discussing how other state tree farm committees were handling certification and funding their organization. Some states chose to immediately start charging their members an annual fee. This met with limited success. Several states lost a significant number of tree farmers who decided that they were not going to pay for something they had been getting for free.

Other states ended up initially losing a fair number of members but then immediately began picking up new members to a point now after 3 years they have more members than before the required annual fee. In South Dakota, we decided that we were going to slowly transition into an organization that would be dually funded by sponsors and members by 2019. In 2016, we successfully identified prospective sponsors/donors who we asked to make a 3 year financial commitment to our organization. Included in these donors are 6 SDFFA board members. Using the proceeds from these sponsors, we were able to fully fund our programs activities for the last 3 years.

During this time our membership committee, under Doug Miller's leadership, has offered many benefits and values to our members. Included in this, is making sure that county assessors understand and value small family forests as agricultural properties. We felt that in order for us to ask for membership fees, there should be great value. So that brings us to 2019 as we transition into requiring our members to have as they say "skin in the game". We believe we have and will provide great value to our members. It is important to note that memberships will still only supply about 40% of our total projected income going forward. During 2019, our committee will be talking with our members about their concerns and ideas of how to continue making South Dakota Family Forest Association the premier forest landowner organization in South Dakota.

Donor Appreciation Barbecue

South Dakota Family Forest Association held its second annual Donor Appreciation Barbecue at Paul and Julie's Schipke's tree farm this fall. It was well attended with over 20 people enjoying a great barbecue provided by the one and only Parks Brigman. Paul's handiwork was on full display as the attendees were able to view an extraordinary rock tower that he and his family built. Housed in the tower, Paul has two real cannons that shoot real cannon balls. Wow. It was quite the sight and sound when the 30 pounder pulverized the air powering the cannon ball 400 yards across the valley.



One of the highlights of our gathering was to recognize the Neiman family for their generous support for and guidance to SDFFA and also for their long term commitment to "Sustainable Forests and Sustainable Communities" in the Black Hills for over 4 generations.

Sawyer Memorial Park Aspen Project

Rocky Mountain Elk Foundation volunteers from the Gold and Northern Hills Chapters, along with Sawyer Memorial Board of Trustee members finished constructing an aspen regeneration protection fence project on Sawyer Memorial Park. It took over 321 volunteer hours of work to put up two, 6 foot woven wire fences and ½" cable around two areas totaling about 3 acres. The cost of the fence materials and some other costs were provided for by grants from the Rocky Mountain Elk Foundation and the Lawrence County Conservation District. The ½" cable was donated by Butte Electric Cooperative.

In May, 2015, our national organization, the American Tree Farm System, facilitated a 1 ½ day Strategic Planning session. This session was the genesis for a major change to our organizational structure. With a "Certification" objective, our new structure focused on committee establishment and was dedicated to identifying and accomplishing "value-added goals" on behalf of you, our membership.

This newsletter communication proudly announces the successful achievements of your SDFFA over the past three years, 2016 through 2018! Please take some time to review and analyze the enclosed display showing the successes of each committee. We're hopeful your assessment concludes that your SDFFA has delivered exceptional results, in such areas as access to valuable knowledge / education / training resources, effective networking with forestry professionals / other tree farmers and responsiveness to your needs, such as advocacy with state / local officials, to mention a few.

Based on the above "successes" documentation, we're hopeful that you, our members, will agree to financially support the SDFFA. Review and Analysis of September Membership Survey

Question 1: How would you describe your current understanding of the relationship between the ATFS SDFFA and SDTF Program, as it applies to you and your property?

Results: 83% of the respondents indicated only a "fair" or "unsure" understanding.

ACTION: The SDFFA leadership needs to continually communicate the relationship between these three entities.

Question 2: In what areas do you think the SDFFA needs to improve as an organization? Select two.

<u>Results</u>: Respondents indicated a need to improve – top two: 47% Communications and Advocacy; 32% Membership and Education.

ACTION: None identified, at this time.

Question 3: Since our last survey in 2016, what SDFFA efforts have been most valuable to you? P

<u>Results</u>: <u>Top Four "Most Valuable"</u>: Connect with a forester / tree farm inspector, Tax Assessor Workshop, Semi-Annual Newsletter, and Relevant Communication(s). <u>Bottom Two "Least Valuable"</u>: Provided access to certified woods markets, Summer Socials.

ACTIONS: 1) Newsletter Addition – Communicate the availability and roles & responsibilities of Allyssa Gregory and Dave Hettick, as SDRC&F Service Foresters, and Consulting Foresters. 2) The Membership & Education and Communications & Advocacy committees are to sponsor another Tax Assessor Workshop. 3) Continue the "Educational Reminders" process by adding additional, relevant topics, such as Standard 4: Protecting the Air, Water and Soil, as it relates to weed management. Further, communicate other important communications, such as the long-eared bat status/actions, ATFS activities, etc. 4) Potentially, partner with the Lawrence County Conservation District to develop appropriate Workshops and Field Days (e.g. Weed Management). Consult with Dave Thom to build on the successes of the Custer County Conservation District.

Question 4: Overall, what do you value most from membership in SDFFA? Prioritize your top four.

<u>Results</u>: <u>Top Four "Most Valuable"</u>: Advice from a forester / tree farm inspector, Local Advocacy (county, state government), Workshops / Field Days, Certification of Wood Products from Your Land. <u>Bottom Two "Least Valuable"</u>: Socials / Awards Events, General Membership Meetings.

ACTIONS: See ACTIONS section for Ouestion 3 above.

Question 5: Specific to your tree-farm property, what additional SDFFA support do you need to better accomplish your management plan's goals and objectives?

<u>Results</u>: Top Responses – (10) "Nothing at this time", (2) Estate Planning, (2) Respect by others of our private property.

ACTION: Estate Planning workshop tentatively scheduled for January, 2019.

Question 6: Regarding AG property / tax issues, do you have any recommendations as to how the SDFFA can better serve our tree farm members?

Results: Eleven (11) respondents indicated a need to be proactive at advocacy, such as actively contacting and educating county assessors and other policy makers. Two (2) respondents indicated a need for changes on their respective weed boards.

ACTION: Need to execute more Advocacy actions for 2019.
