South Dakota Family Forests Association (SDFFA) is a volunteer organization and its success rests squarely on the shoulders of energetic, reliable individuals who are committed to the principles of managing forestland in a sustainable manner with the major focus on healthy-forest management and wildlife habitat enhancements. One volunteer, Paul Schipke, has decided to "retire" from his SDFFA leadership positions, which he has held since 1999. SDFFA has been blessed to have Paul's leadership skills, positive energy and reliable character on full display for the past 20 years! Since 1999 when Paul and his wife, Julie, became certified tree farmers, he has continuously served on the SDFFA Board of Directors and on the Executive Committee, with his most recent assignments being Chairman and Vice-Chairman.

Examples where he directly or indirectly represented the SDFFA include:

A ten-year member of the Lawrence County Timber Advisory Committee.

For six years, conducted tree planting and field education sessions for the 4H Club of Belle Fourche.

Testified before the SD House Agriculture committee, in support of a "healthy forest" resolution, targeting Mountain Pine Beetle and Wildfire management initiatives.

Has made numerous presentations, in support of the SDFFA organization (e.g. Dakota Society of American Foresters, Custer County Conservation District).

Since 1999, they have demonstrated a personal commitment to exceptional forest-management principles. The love and

passion for the health and well-being of their 300-acre, tree farm is evident from the below actions and recognitions as examples.



- Have burned almost 700 hand-stacked brush piles while completing fuel reduction management
- Hand planted almost 21,000 Ponderosa, pine seedlings after major portions of their property were damaged from the 2002 Grizzle Gulch Fire.
- Actively mitigated the MPB infestation by using salvage logging and "cut & chunk" treatments affected by Mountain Pine Beetles (MPB)
- Installed five underground mine-openings to protect wintering sites for bats.
- Received the Lawrence County / Butte County "Conservation Citizenship Award" in 2013.

So, "THANK YOU" Paul and Julie for your SDFFA involvement and the energy you have displayed in support of SDFFA initiatives, for your twenty years of leadership, your continuing role as a member and for your friendship as those of us within the SDFFA family have enjoyed a positive, personal relationship with you and Julie.

#### VALUE ADDED AGRICULTURE & FAMILY FORESTS

To maintain proof of agriculture income for ag tax status on our small tree farm, we need to maximize profit with the limited amount of dead timber we harvest for firewood each year. We only harvest dead and downed trees for firewood, to reduce the fuel load and wildfire danger. The trees we are harvesting now were killed in the May 2019 blizzard.

In the Black Hills, split stacked firewood averages about \$100 per pickup load. But some local retail stores in Rapid City sell small bundles of mostly out-of-state firewood for up to \$8 each. In my own opinion, it makes little sense that area retailers offer firewood shipped in from hundreds of miles away when there is ample local supply. To better capitalize on this market, we came up with the Camp Fire Kit<sup>TM</sup>. It's a paper bag full of firewood split into various sizes for kindling and longer burning wood. The paper bag can be ripped up and used to start the campfire. The back of the bag has a QR code link to fire safety information and a number of safety reminders.

COVID 19 limited our ability to produce in 2020. The small amount of product we produced sold well in one local retail store. We found Camp Fire Kit sales yield a five-fold increase in profit over the per-pickup load price. We hope to expand sales in 2021.

We think this idea can benefit other members of SDFFA, and we are willing to work with any members want to use this concept to

help their own family tree farms achieve proof of agriculture income. There may be incentives for value added agriculture cooperatives in the state and we are exploring these opportunities.

#### SOUTH DAKOTA LIEUTENANT GOVERNOR VISIT

In late August 2020, the Lieutenant Governor SD Department of Agriculture Larry Rhoden, took a tour of the Black Hills logging and forest industry. Hosts of this visit included the South Dakota Department of Agriculture Division of Resource Conservation and Forestry Division, Neiman Timber Industry, and SDFFA. The purpose of the tour was to demonstrate not only the value of the family forests to the timber industry but to forest health in general, and the importance of continued help from the state with professional advice and cost-sharing programs.

The day-long tour started with a visit to Neiman Industry's Spearfish sawmill, an active logging site, Case #1 where the first federal timber sale in the country occurred and ended at the Bob Burns/Mary LaHood Family Forest. This farm has been in the family since the 1800s and is actively managed for last 25 years. Projects completed include: two timber harvests and over 20 other projects were completed including: wildlife habitat improvement, pre-commercial tree thinning, hardwood and meadow enhancements, and spring improvements.

As a Meade County rancher the Lt Governor was well aware of the importance of grass cover and a fibrous root system to stabilize the soil, absorb rain water and improve wildlife habitat. Overcrowded timber stands contain a mat of pine needles and cones that forms an almost impervious barrier to rainwater and creates essentially a biological desert with a few spindly plants trying to survive in the dense shade and dry conditions.

## SDFFA/ATFS INSPECTORS OUTREACH GRANT

With the shared common goal of engaging more landowners in sustainable forest management and the recognition that increasing and strengthening the inspector community is a necessary component of that, ATFS and SDFFA have teamed up on an Inspector Engagement Pilot Program. Actively working to grow the inspector community and capacity will benefit not only SDFFA, but will serve to provide useful data for other states to develop and model similar programs.

### 2020 THIRD PARTY AUDIT RESULTS

In 2020, the South Dakota Family Forests Association was one of several states that participated in a review of the American Tree Farm System through a third-party assessment conducted by PricewaterhouseCoopers (PWC). These audits are a useful measurement for the American Tree Farm System (ATFS) to identify both areas of success and need for improvement to ensure ATFS is providing landowners with the information they need to manage their forested properties, and subsequently ensure a credible certification system which creates opportunities for family forest owners.

The PWC auditor reviews the organization's records and typically conducts a one-hour visit of randomly-selected tree farm properties who have been notified in advance. This time, due to COVID 19, instead of site visits landowners participated in a phone interview. They shared their stewardship plan goals and objectives, and answered questions pertaining to the 2015-2020 Standards of Sustainability as applied to the practices on their property.

Twenty-three instances of exceeding the standards were recognized. Some of them included: extensive record-keeping; utilization of GPS mapping system; having an MOU with the fire department for fire mitigation thinning training; re-seeding slash piles with native grasses and wildflowers; creating fuel breaks to protect adjacent neighborhoods; constructing a pedestrian-only gate for hikers; requiring contractors to wash equipment prior to coming onsite to prevent the spread of invasive species; working on research for game studies, prescribed burning, shelterbelts and new grinding equipment; arranging permission to clear beetle trees from USFS property near landowner's property line; working jointly with the Rocky Mountain Elk Foundation; and conducting tours for SD Secretary of Ag, tax assessors, church and environmental groups.



Management paths used included cutting and removing all competitive tree species such as ponderosa pine (Pinus ponderosa) and any dead or dying quaking aspen. To discourage wildlife browsing of regeneration the area was fenced.

### NATIONAL TREE FARMER OF THE YEAR FINALIST

Mary LaHood and Bob Burns of the LaHood-Burns Family Forest advanced to the final eight selection in consideration for American Tree Farm System (ATFS) National Outstanding Tree Farmer of the Year. The country is divided into four regions and two tree farms from each of the four compete for the regional and national honors.



The family was featured in the Woodland Fall 2020 magazine where the selection process as well as the steps forward was explained. "America's family forests are vital for clean water and air, wildlife habitat, and sustainable wood supplies. The American Tree Farm System, AFF's signature program, is the country's largest sustainable woodland program, with a network of more than 70,000 family forest owners managing 19 million acres of forestland. To be considered for the ATFS National Outstanding Tree Farmer of the Year

award, nominees must exhibit exceptional forest stewardship to protect and improve forest resources and promote forest stewardship within their communities. This year, the global COVID 19 pandemic put a pause on the 2020 selection process. After much discussion and input from the Review Committee, inspectors, and finalists, the judging process and field visits with the current eight finalists will be held in late spring 2021 to ensure a safer, more equitable outcome."
